Digital inclusion funding

Glasgow Kelvin College has received £106,213 of funding to tackle digital poverty. This has enabled the College to procure 366 Chromebooks (at a cost of approximately £260 per device). All purchased devices have been distributed to students who applied and met the criteria as set out by the Scottish Funding Council. In addition, a further 50 MiFi 4G dongles have also been distributed to students who required support to access the internet.
