Finance at a Glance

Students are responsible for their fees irrespective of whether these are being paid by someone else on their behalf. It is important that, prior to enrolment, you have established whether you are liable to pay fees and how these are to be paid. The tuition fee you pay will vary depending on your fee status and your course of study and is payable on enrolment. It is expected that students pay the full fee for any programme of study prior to the commencement of the programme.
