Executive Summary

Since 31st December 2016 the Procurement Reform (Scotland) Act 2014 (PRA) required any public organisation which has an estimated annual regulated¹ spend of £5 million or more to develop a procurement strategy and then review it annually. Organisations required to develop and publish a procurement strategy were also required to publish an annual Procurement Report (APR), reflecting on the relevant reporting period of the procurement strategy.

This report covers the period of 1 January 17 – 31 July 2018 and addresses performance and achievements in delivering the Glasgow Kelvin College organisational procurement strategy during this period.

Glasgow Kelvin College has analysed third party expenditure and has identified that over the period covered by this report the following expenditure has occurred:

- EU regulated procurements amounted to £1,040,462.00. There were 4 such procurements completed².
- Lower value regulated procurements³ amounted to £313,962.00. There were 4 such procurements completed³.

More detailed information on the regulated procurements, sorted into procurement categories, is provided in Sections 1 and 2 and in Annex A of this report.

Glasgow Kelvin College has over 355 active suppliers with whom the College did business in the reporting period and the total procurement expenditure was £ 7,196,679.23 of contracted and £994,483.89 non-contracted. Total spend was £ 8,191,163.12.

The College has been optimising use of national and sectoral collaborative contracts and frameworks. As well as bringing leverage based savings, the burdens of risk, contract and supplier management are shared and the number of resource-intensive formal local tenders that need to take place is reduced significantly. From 1 Jan 2017 to 31 July 2017 approximately 23% of the College spend went through collaborative agreements.

This report comprises seven sections, the first five cover mandatory reporting.

Section 1: Summary of Regulated Procurements Completed

Glasgow Kelvin College strongly believes in conducting its procurements in an open and inclusive manner with procurement objectives aligned to the College's Strategic Plan.

The detailed summary of regulated procurements completed is set out in Annex A. That information, coupled with the publication of the College's [Contracts Register](#) and the systematic use of Public Contracts Scotland and Quick Quotes, provides complete visibility of the College's procurement activity over the reporting period.

In Annex A, information is set out to show lower value regulated procurements completed and EU regulated procurements completed. It distinguishes use of collaborative frameworks from contracts led by the College.

For each completed regulated procurement the information provided shows:

- the date of award
- the start dates
- the category subject matter
- the name of the supplier
- estimated value of the contract – total over contract period
- collaborative or institution owned
- the end date provided for in the contract or a description of the circumstances in which the contract will end.

Section 2: Review of Regulated Procurement Compliance

Where appropriate, Glasgow Kelvin College has made use of collaborative contracts to deliver improved contract terms, supported contract and supplier management, sustainable procurement outcomes and value for money (the best balance of cost, quality and sustainability).

In making its regulated procurements every care has been taken to ensure that the College awards the business to suppliers who are capable, reliable and who can demonstrate that they meet high ethical standards and values in the conduct of their business.

In the period covered by this report the College has conducted all its regulated procurements in compliance with EU Treaty Principles of equal treatment, non-discrimination, transparency, proportionality and mutual recognition.

Successful delivery against the procurement strategy objectives is part of an action plan that seeks incremental improvements to process and outcomes over time. The action plan is based on the College assessment against the Scottish Government Procurement and Commercial Improvement Programme (PCIP). The PCIP is a useful tool through which can provide valuable benchmarks by which necessary improvements might be identified, consulted over and implemented.

The College's most recent PCIP was conducted in 2016. Due to the College expenditure it was subject to a "lite" assessment. Glasgow Kelvin College achieved a score of 80% and a banding of Gold. This scoring demonstrated excellent performance across the core assessment areas and contract compliance is increasing year on year.

Glasgow Kelvin College has Procurement Processes and sign off arrangements that are consistent with the guidelines set out in the Procurement Journey and that have met procurement objectives and obligations.

Section 3: Community Benefit Summary

For every procurement over £4m, Glasgow Kelvin College will consider how it can improve the economic, social or environmental wellbeing of its area through inclusion of community benefit clauses, to assist with achieving sustainability in contracts activity, including targeted recruitment and training, small business and social enterprise development and community engagement. During the 17-18 period the College did not have any procurement of this value.

However the general College policy on identifying community benefit requirements is to conduct a risk and opportunities assessments through stakeholder consultation and engagement – on a case-by-case basis the question is asked, ‘could a community benefit clause be usefully included’? Where relevant and proportionate to the subject matter of the procurement, the requirement is then built into the procurement specification and into the eventual conditions of contract performance.

Where applicable, as part of the tendering process, suppliers are invited to describe their approach to delivering community benefits or achieving social value through a contract. Relevant community benefits are cited such as:

- providing ‘upskilling’ opportunities (e.g. Toolbox talks) with students and staff,
- employment, student work experience and vocational training opportunities,
- apprenticeships,
- local subcontractor opportunities available to SMEs, 3rd sector and supported businesses,
- direct involvement in community based schemes or programmes,
- equality and diversity initiatives,
- supply-chain development activity,
- educational support initiatives,
- to minimise negative environmental impacts, for example impacts associated with vehicle movements and/or associated emissions and impacts on protected areas, buildings or sites.

Bidders are invited to describe how such benefits will be successfully delivered through the contract and promoted to contract users. Where community benefits are included in a procurement (at or above the £4 million threshold), the award notice would include a statement of the benefits that are expected to be derived from the contract.

Glasgow Kelvin College has awarded 8 regulated procurement contracts over the reporting period. None of these were over £4 million in value.

In the reporting period, the following community benefits were fulfilled:

1. Student work experience and vocational training opportunities
2. Local subcontractor opportunities available to SMEs, 3rd sector and supported businesses,

Section 4: Supported Business

For all regulated procurements, Glasgow Kelvin College considers whether the service provision could be fulfilled by a Supported Business, whilst remaining compliant with EU and ensuring value for money for the College.

The College did not reserve any contracts for supported businesses in this period due to the nature of the requirements. However during this reporting period GKC has been in discussion with Inclusion Scotland and a placement has been agreed for an assistant to join the College Equalities and Diversity team, late 2018. The College publishes its commitment to Access and Inclusion and its Equalities Mainstreaming Report separately.

Section 5 – Future Regulated Procurements

Glasgow Kelvin College is keen to encourage competition by promoting optimal participation in its procurement process and achieve better value for money in its procurements. One method of achieving this is to give notice to suppliers of tendering opportunities that are expected to commence over the next two financial years after the period covered by this report.

In preparing this forward projection of anticipated regulated procurements, it is difficult to be precise about providing details of actual requirements. Over a forecast period of two years it is very probable that circumstances and priorities will change so the list of projected individual regulated procurement exercises outlined in Annex D should be viewed with this caveat in mind.

The information provided in Annex D covers, (where the information is available):

- the subject matter of the anticipated regulated procurement
- whether it is a new, extended or re-let procurement
- the expected contract notice publication date
- expected award date
- expected start date
- the estimated value of the contract.

Section 6 – Content for Consideration

Legislation Update

Procurement has worked with Governance to implement new terms and conditions for all regulated tender processes to incorporate recent changes to Data Protection Legislation, Criminal Finances Act and Modern Slavery Act. A new process has been implemented to ensure GDPR risk is assessed prior to commencing a regulated procurement. The college is working with suppliers to ensure their processes are robust when handling the College's data.

Gateway

During the period of this report Glasgow Kelvin College has worked closely with APUC introducing the PECOS "Gateway" system. The Gateway allows for a requisitioner to be

able to access online linked supplier catalogues. Using an online basket the requirements can be transferred directly on to a PECOS order ensuring GKC are receiving all discounts that are available.

Below Regulated Expenditure

In addition to the regulated contracts awarded evidenced in Annexes A and B within this report, Glasgow Kelvin College awarded 10 contracts which were below the regulated expenditure⁴. These amounted to a total spend of £188,402.58.

Achievements

PECOS/Gateway – During the last 8 months of this reporting period the Procurement Manager has trained a number of College staff to be able to identify contracted suppliers for their requirements and how to ensure contract prices and terms and conditions are applied.

Glasgow Kelvin Velocity - Through support from GKC Student Association and internal stakeholders Glasgow Kelvin College has built a Cycle Hub for students, staff and the public. Services on offer are: drop-in bike fix sessions; provision of information for route planning; led rides and promotion of active travel; a social space; and bike breakfasts. Glasgow Kelvin College's Velocity Cycle Hub has won a prestigious award for sustainability at the Education Buildings Scotland 2018 Awards. This accolade is a significant acknowledgement for the Velocity Cycle Hub and the hard work undertaken to encourage students, staff and the community to adopt a healthy, sustainable lifestyle.

White Ribbon Campaign: Glasgow Kelvin College won a national Green Gown Award this year for the Student Association led campaign calling for action against violence towards women. Glasgow Kelvin College is the first College in Scotland to achieve White Ribbon Status. Campaign involved sourcing, dissemination and presentation of educational material to students and staff. The information was also accessed by the public. Local businesses have also become involved with the campaign in collaboration with GKC.

East End Garden - GKC has secured funding from the Scottish Landfill Community Fund for the development of a Community Garden at our East End campus. The Garden will be open to the public, and will act both as a social and a learning space. Going forward with this project GKC Procurement will work with the Project & Sustainability Officer to ensure environmental sourcing.

Section 7 – Compliance with Procurement Strategy

Our procurement policies and procedures align fully with the Scottish Government Procurement Journey following best practice procurement in a legally compliant manner. Feedback from suppliers who have participated in the college's tenders has been highly positive with only a few specific suggestions for improvements and there have been no complaints or legal challenges to date.

In order to deliver strategic procurement objectives and to comply with the general duties and specific measures of the PRA, a number of critical areas have been identified for continual annual review including:

i) Organisational Spend - The Procurement Manager analyses organisational spend on a yearly basis to identify opportunities to combine individual commodity spend into larger more cost effective local contracts. Spend on local contracts has steadily increased demonstrating improved purchasing compliance across the organisation.

ii) Transparency. All procurements are undertaken in full compliance with the principles of equal treatment, non-discrimination, transparency, proportionality and mutual recognition. All regulated procurements are published on Public Contracts Scotland (PCS) with output based specifications and clear evaluation criteria to ensure our contract opportunities are accessible to as many bidders as possible.

iii) The Sustainable Procurement Duty - GKC gives consideration to the environmental, social and economic issues relating to all regulated procurements. These and other relevant elements are reviewed in every individual procurement strategy per regulated tender to ensure opportunities to improve sustainability in our procurements are not overlooked. GKC has appointed a Project and Sustainability Officer who works closely with procurement and whom also supports APUC in the use of its "Sustain" sustainability assessment web portal, developed to record the social, ethical and economic standards and compliance of suppliers and identify areas of risk and opportunities for influence.

iv) Community Benefits – Where possible GKC includes appropriate Community Benefit requirements in relevant contracts and in this period one Contractor has made commitments. Further detail is provided at Annex B below.

v) Living Wage - The College is a Living Wage Foundation Accredited Employer and Contractors are encouraged to pay their staff in accordance with the Living Wage Foundation minimums known as the Real Living Wage. The Cleaning and Catering suppliers have committed to working with the College to pay staff working on the College Contract the Real Living Wage in the next financial year.

vi) The Procurement of Fairly and Ethically Traded Goods and Services. GKC sources goods giving consideration to fair and ethical trading and equivalent offerings wherever possible and relevant. The Catering Contractor has included a variety of fair and ethically traded food choices in all outlets.

vii) The Provision of Food and Improving the Health, Wellbeing and Education of Communities in the College's Area, and the Promotion of the Highest Standards of Animal Welfare. The Catering Services Contract has committed to the delivery of fresh, seasonal and health food offers whilst maintaining the highest standards of animal welfare through the use of certifications such including Farm Assurance Schemes, sustainably sourced fish and non-caged hen eggs. Other food purchases are made using the TUCO (The University Caterers Organisation) Contracts. TUCO is committed to driving the health and well-being agenda on behalf of the education sector with sustainability embedded into all contracts. All TUCO suppliers must undergo rigorous assessment of environmental credentials.

x) Performance Management - Whilst GKC Procurement has accomplished a significant amount during the reporting period seen with the rise in contracted compliant spend, we recognise that there is more we can do to add value across the College and drive value and efficiency savings during the life of the Contract. A key priority for Procurement in the immediate future is to work closely with Key Stakeholders across the College and agree a more formal and consistent approach to Contractor Performance Management (CPM).

Annex E - Glossary of Terms

APUC's Code of Conduct - APUC and its client community of colleges and universities is committed to carrying out procurement activities in an environmentally, socially, ethically and economically responsible manner and to entering into agreements and contracts with suppliers that share and adhere to its vision. To demonstrate this commitment, current and potential suppliers are asked to acknowledge their compliance with the principles of the APUC Supply Chain Code of Conduct with respect to their organisation and their supply chain.

Category of supply is a collection of commodities or services sourced from the same or similar supply base, which meet a similar consumer need, or which are inter-related or substitutable.

Community Benefits are requirements which deliver wider benefits in addition to the core purpose of a contract. These can relate to social- economic and or environmental benefits. Community Benefits clauses are requirements which deliver wider benefits in addition to the core purpose of a contract. These clauses can be used to build a range of economic, social or environmental conditions into the delivery of institutional contracts.

EU regulated procurements are those whose values require that they are conducted in compliance with the Public Contracts (Scotland) Regulations 2015 and the Procurement Reform (Scotland) Act 2014.

Hub (Spikes Cavell) - The Scottish Procurement Information Hub is provided by Spikes Cavell as a spend analysis tool allowing organisations to: -

- Identify non-pay spend on external goods and services
- Identify key suppliers and how many transactions are made with each
- Highlight common spend across suppliers and categories
- Identify spend with SMEs and/or local suppliers

This information means that individual organisations and Centres of Expertise can identify where collaborative opportunities might exist and where transactional efficiencies could be made.

Hunter - Hunter has been developed by the eSolutions team. It is a database solution which uses standard Microsoft packages (Access and SQL Server) enabling organisations to effectively monitor and report on collaborative contracting activities.

As a solution, it is operational within the HE/FE sector in Scotland and is also being utilised by the HE consortia in England and Wales that also provide collaborative contracting services to the sector. Hunter has a multi-level structure which allows consortia to share collaborative agreements, make them visible to their member organisations, and in turn enabling them to record their own contracts.

Institutional Dashboard - is the area within the APUC Buyers Portal being developed by the APUC eSolutions team providing easy access to institutions' key management reporting data

being recorded centrally through **Hunter**. The dashboard currently hosts key regulatory procurement information on Contracts Registers, forward contracting plans, expenditure reporting and APR Data. The list of reports is planned to expand to cover savings and PCIP dashboard data.

Lotting - the Public Contracts (Scotland) Regulations 2015 encourage the use of lots (regulation 47), to promote competitiveness and to facilitate the involvement of SMEs in the public procurement market, by considering the appropriateness of dividing contracts into lots to smaller contracts

Prioritisation - the Sustainable Public Procurement Prioritisation Tool which is a tool to aid all procuring organisations across the Scottish Public Sector designed to bring a standard structured approach to the assessment of spend categories.

Procurement Journey is public procurement toolkit with guidance and templates on the procurement process to facilitate a standardised approach to the market and contract and supplier management.

Procurement & Commercial Improvement Programme (PCIP) replaced the previous Procurement Capability Assessment (PCA) and focuses on the policies and procedures driving procurement performance and more importantly, the results they deliver.

PCS (Public Contracts Scotland) is the national advertising portal used to advertise all public sector goods, services or works contract opportunities.

PCS-Tender is the national eTendering system, and is centrally funded by the Scottish Government. The system is a secure and efficient means for buyers and suppliers to manage tender exercises online. The standard templates enable buyers to create consistent tender documentation.

Segmentation is the division and grouping of suppliers or contracts in relation to spend and its criticality to business.

Small and Medium Sized Enterprises (SMEs) encompass –

Micro enterprises: enterprises which employ fewer than 10 persons and whose annual turnover and/or annual balance sheet total does not exceed £1.57 million.

Small enterprises: enterprises which employ fewer than 50 persons and whose annual turnover and/or annual balance sheet total does not exceed £7.86 million.

Medium enterprises: enterprises which are neither micro nor small, which employ fewer than 250 persons and which have an annual turnover not exceeding £39.28 million, and/or an annual balance sheet total not exceeding £33.78 million.

Supply Chain encompasses all activities, resources, products etc. involved in creating and moving a product or service from the supplier to the procurer.

Supported business means an economic operator whose main aim is the social and professional integration of disabled or disadvantaged persons, and where at least 30% of the employees of the economic operator are disabled or disadvantaged persons.

Sustain - is the APUC supply chain sustainability web portal, a central hub where sector suppliers can complete and store sustainability compliance data. The portal is the core supply chain sustainability tool supporting HE and FE institutions and their suppliers in delivering a transparent, environmentally positive, ethical and socially responsible supply chain.

Sustainability Test- This tool is designed to help embed relevant and proportionate sustainability requirements in the development of contracts. Used in conjunction with The Scottish Prioritisation Methodology it gives clear direction on embedding sustainable action in procurement exercises.

Sustainable Procurement A process whereby organisations meet their needs for goods, services, works and utilities in a way that achieves value for money on a whole life basis and generates benefits, not only for the organisation but also to society, the economy and the environment.

Third-Party Expenditure is calculated based upon the total value of invoices paid per annum, excluding VAT, to all suppliers for the purchase of goods and services. It is defined as including: goods – tangible products such as stationery, which are often also known as supplies. Services – provision of an intangible product such as refuse collection, elderly home care, whether carried out internally or externally. Works – including construction works and utilities – energy costs. It excludes employee costs, non-cash expenditure (e.g. depreciation), grants, trust payments and other non-controllable payments to other publicly funded bodies but should include spending on agency staff, capital expenditure and programme spend on commodities and services.
